

**New fees for applications being introduced in November 2018
Deck and Engineering Notice of Eligibility (NoE) and Certificate of Competency
(CoC)**

Where an application in the below table for Deck and Engineering is withdrawn or rejected the refund will be as follows:

- £152 if an NoE **has not** been issued
- £130 if an NoE **has** been issued.

Where an application in the below table for CECs is withdrawn or rejected prior to the issue of a CRA the refund will be £50, no refund applicable if a CRA has been issued.
